

Junior Counselor Program

The Junior Counselor (JC) program is for high school students who have completed at least one year of high school. The goal of the JC program is to provide leadership and job-related training and experience.



Please read the following information carefully.

The application deadline is May 1, 2019. All parts of the application including one reference letter from a non-family member is due by this date. Applications can be submitted in person or by mail to the Yvonne Richardson Community Center (240 E Rock St; Fayetteville, AR) or by email to slivengood@fayetteville-ar.gov. Applications submitted after deadline will only be considered if positions are still available. We hope to complete placements by May 15th, 2018.

REFERENCE LETTER: If reference is sent via email it must be from a school or business-related email account. References from gmail, yahoo, hotmail, etc. will not be accepted. Hand written reference letters must be in a sealed envelope with reference's signature across envelope's seal.

INTERVIEWS: The YRCC Program Coordinator and/or Director will conduct interviews, if necessary, to determine if applicant is a good fit for the Junior Counselor program.

ORIENTATION: All youth accepted into program will be required to attend orientation as part of their leadership training. Orientation will be May 30- May 31 from 10am-3pm each day. Lunch and snack will be provided. Junior Counselors who have attended training the year before will only be required to come to training on May 31.

Placement in program is based on professionalism and enthusiasm, and at the discretion of YRCC staff. Junior Counselors are not required to be at camp for all eight sessions, unless they so desire. However, we expect a commitment to the weeks they have chosen to participate in the JC program barring any illness or emergency. We have limited spots (5-6) each week for JC's. Please only sign up for weeks you can attend the entire day, all week long. Exceptions can be made on a case by case basis.

- I will be responsible for my personal belonging and will not hold the Yvonne Richardson Community Center or City of Fayetteville for their loss or damage.
- I will treat all equipment provided for my use with care. I understand that I will be assessed for damages to any equipment if my use of such equipment is negligent or abusive.
- I will use all required safety equipment and follow safety rules and procedures.
- I understand that if I am sent home early due to misconduct, it will be my parent's or guardian's responsibility to pick me up if I am not providing my own transportation. I will have to meet with my parents or guardians and the Camp Director if I would like to be readmitted to the program.
- I understand that to receive community service recognition that I will need to keep appropriate documentation and evaluation of my experience.
- I understand that I cannot drive any camper during camp hours or to and from camp.
