Award Review Criteria: The Environmental Action Committee will review application narratives based on how the project or initiative meets any, or all, of the following criteria:

- *Impact:* The project or initiative should have a demonstrable positive sustainability, resiliency, education and outreach, or environmental impact on the community.
- *Reach:* The project or initiative should have broad reach in the community and should be worthy of celebration and attention for its accomplishments.
- *Innovative and Creative:* The project or initiative should reflect a new concept, technology, or practice or it should employ new or improved ideas that are more sustainable or environmentally beneficial.
- *Replicable and/or Scalable:* The project or initiative should be easily replicated, or scaled, for other neighborhoods, communities or municipalities.
